### MoU for Software Development Agreement

THIS AGREEMENT ("MoU") is executed on <u>)04-12-2019</u> at Pune between <u>Zerton Engineering Services Pvt. Ltd.</u> ("Company"), with its principal place of business located at "Shop no 256, Jai Ganesh Vishwa Complex, <u>Vishrantwadi</u>", Pune and <u>MMIT,Lohegaon</u> ("Client"), with its principal place of businesslocated at <u>PUNE</u> and shall be effective as of 05-12-2019 (the "Effective Date").

WHEREAS, Company is engaged in the business of software development, designing and development of mobile applications for various educational institutions as per their requirements.

WHEREAS, Client wishes to utilize the services of Company in connection with the development of certain software identified as \_Student Connect\_ (the "Software").

NOW, THEREFORE, Company and Client agree as follows:

### 1. Scope of Services

Company will perform the services described in Exhibit A (the "Work"), in order to develop and implement the Software according to specifications and completion time set forth therein. Client will cooperate with Company's reasonable requests for information and data necessary for the completion of the Work. Any delay by Company in completion of Work within completion time due to a reason directly attributable to Client shall not be considered delay in completion and accordingly shall not amount to breach of this Agreement.

#### 2. Term and Termination

Unless terminated as provided herein, this Agreement shall commence on the Effective Date. Once the software is developed and delivered as per Work in Exhibit A, the Company's role as software developer is extinguished. For the purpose of providing software updates, upgrades and regular maintenance services, the term of this shall be **2 years** from the effective date.

This Agreement may be terminated in the following situations:

- i. This Agreement may be terminated by the other Party if the Defaulting Party does not rectify the Default within the Cure Period; for the purpose of this Agreement, "Default" means and shall have said to have occurred, if, any Party:
  - a. Commits an act which is against the terms and conditions of this Agreement; or

 Fails to comply with the duties or obligations or specifications as provided in this Agreement; obligation except in a situation of Force Majeure.

On the notice of any Default by either Party ("Defaulting Party"), the Other Party shall send a written notice to the Defaulting Party stating, in detail, the Default committed by the Defaulting Party and provide 30 days ("Cure Period") to the Defaulting Party to carry out all necessary activities to make good the Default.

If the Defaulting Party fails to carry out all such activities to make good the Default within the Cure Period, the Other Party shall have the right to terminate this Agreement

ii. Either Party is in violation of any Applicable laws, except in the situation of Force Majeure;

iii. Either Party is adjudicated as bankrupt, or goes into liquidation or is prohibited to perform their obligations;

iv. By giving a written notice of at least 150 (One Hundred and Fifty) clear days to the other Party;

Any termination by a Party shall not affect any liabilities incurred by the other Party prior to the termination of this Agreement or for acts performed during the pendency of this Agreement which may result in a dispute post termination of this Agreement.

In case of termination of this Agreement by Client, the Client shall be liable to pay an amount equivalent to Work completed by the Company

### 3. Price and Payment Terms

Student Connect Software-as-a-Service (SaaS) solution shall be based on freemium model. Company will give the SaaS & software for free for a period of 1 years from the execution date this agreement, post which the Company shall charge an annual fee of some amount (approx. Rs. 25 i.e negotiable) per account per month to the Client for use and maintenance of the Software only if client wants to proceed with use of company services. The new agreement will be signed by both parties.

### 4. Commercial terms

A. Client agrees that, Company may publish, display or exhibit advertisement, commercials or any other media, whether it's own or of a Third Party, on the Software during the term of this Agreement. Right on any revenue earned by the Company due to such publication, display or exhibition shall be that of the Company only. The Client further agrees and has no objection if such advertisement, commercial or media occupies space on the mobile screen.

- C. Company is responsible for development of Software only and no hardware/ machines/server/routers etc. will be provided, unless specifically requested by Client, in which case, the Client shall bear additional procurement and installation costs along with hardware costs.

### 5. Data Storage, Retention, Transfer and Security

The client further agrees that it is obliged to avoid unauthorized access, loss, misuse, disclosure, alteration, and destruction of Data and Personal Information.

The Client agrees that it shall not share, sell, trade or rent your Personal Information to Third Parties for unknown reasons. The Client further agrees that it shall retain complete anonymity in all analytics of the Data and Personal Information

#### 6. Ownership of Intellectual Property

To the extent that Company has received clause 4A of compensation as provided in this Agreement, Company hereby assigns to Client all rights, title, and interest in any intellectual property created of developed by Company for the Software developed as per requirement given by the Client under this Agreement. Client agrees that the Company shall be permitted to use the Data and Personal Information as per Privacy Policies and Terms of Use present on the Software Mobile Application
