

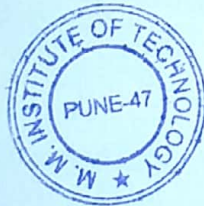
Terms and Termination:

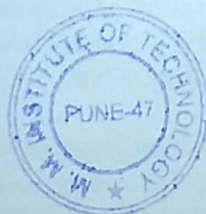



